

# MAFETENG URBAN COUNCIL RAPID ASSESSMENT OF ADOLESCENT SEXUAL AND REPRODUCTIVE HEALTH (ASRHR)



JANUARY 2022

This fact sheet is a summary of the findings of the ASRHR Rapid Assessment undertaken in Mafetena Urban Council as part of an eight-country study<sup>1</sup> from November 2019 to December 2020. The research aims to strengthen youth-led and focused efforts to promote ASRHR through gender and youth responsive local governance. Gender Links Lesotho conducted the study in nine Centers of Excellence for Gender in Local Government.<sup>2</sup> In Mafeteng Urban Council, the study covered the two clinics (LeCoop Clinic and Mafeteng Government Hospital) around Mafeteng Urban Council; 65 respondents: 45% young women and 55% young men (see table overleaf). This fact sheet should be read together with the Lesotho and the Southern Africa ASRHR Rapid Assessment research pamphlets. Key findings include:

### **Accessibility**

- Over 69% of the respondents from Mafeteng Government hospital reported being within 10 km and 64% at Lecoop Clinic however more clinics are needed because this council serves more people as it is in town.
- At least 75% of respondents from Mafeteng Government Hospital said it opens after School while 78% on weekends as compared to 14% at Lecoop and 0% on weekends.
- About (100%) of respondents said both facilities have a comfortable waiting and consultation area.
- The government hospital charges a subsidised fare to accommodate more people.

#### Quality of care

 Almost 97% of respondents confirmed the availability of peer counsellors at the health facilities.

- About 95 % respondents said they received appropriate information with 100% at Lecoop Clinic and 94% at Mafeteng Hospital.
- Overall 71% of young people treated without third party with highest of 86% Lecoop Clinic and lowest of 43% at the Mafeteng Hospital treated with respect, this can only be the fact that Lecoop clinic is private own and their services is way much better than the government.
- Both facilities at 69% confirmed the privacy at the facilities with 64% at Lecoop clinic and 45% at Mafeteng Hospital in terms of confidentiality.
- Sixty-two percent of respondents said the clinic treated them with respect while 46% with confidentiality.
- All the respondents (100%) at Lecoop Clinic confirmed receiving appropriate information as compared to 94% at Mafeteng Hospital.

#### Sexual and reproductive health services

- Forty-two percent of respondents requested contraceptives and almost 90% received; this shows young women have greater access to contraceptives.
- About 48% young women requested pregnancy test and over 100% at Lecoop clinic received the test as compared to 14% at the Mafeteng Hospital, this highlight service delivery between a private owned facility and a government one.
- Overall 29% of young women tested positive.
- Only 45% of young women requested sanitary pads at both facilities and 50% at Lecoop received and 43% at Mafeteng hospital.
- All the young men (100%) requested male circumcision and received appointments.
- Only 10% requested ARVS and 83% received, this
  is amazing as the government is working very
  hard to see that when people get tested they
  are immediately put on treatment if need.
